Under Section (18) of THE RIGHT TO CHILDREN TO FREE AND COMPULSARY EDUCATION ACT, 2009 and Free & Compulsory Education Rights Rules 2011 Clause (11), on the basis of reports received from the officers, permission of honorable DGSE (Punjab) vide Letter No- DGSE/RTE/2016/1276-78 Dated 25/01/2016 St. Sai Sen. Sec. School, Green Field, Majitha Road, Amritsar is granted recognition for classes pre-primary to VIII classes, on the basis of following conditions.

1. Institution/School will not collect any capitation fee and subject the child are his or her parents or guardian to any screening procedure.
2. School will abide section(15) of the act and no child shall be denied admission in the school for lack of age proof. Provided that no child shall be denied admission if such admission is sought subsequent to the extended period.
3. No child will be expelled from school till the completion of elementary education.
4. No child shall be subjected to physical punishment or mental harassment.
5. Under section 21 on completing of elementary education School will Issue pass out Certificate .
6. Time to time School will submit Building Safety Certificate, Fire Safety Certificate and Other Certificate .On expiry of validity of these documents school will renew until these all documents . On Non-Compliance of submitting above said documents, recognition of the School can be cancelled under the RTE Act and Rules.

8. Under Section 23(1) of the Act It is compulsory, teacher should possess minimum qualifications as laid down by an academic authority should be eligible for appointment as a teacher.
9. School will abide by the Rules and directions issued time to time. Other Conditions laid down in temporary Recognition will also applies.

10. School will abide by the Terms & Conditions of the RTE ACT (2009). If it is found that School has Violated any terms & conditions of the RTE ACT/Rules or on the time of grant of Recognition School has Suppressed Material facts then Recognition of the School can be Cancelled.
